

You Can't Hear Them Scream

Roe vs. Wade has brought about millions of murders of innocent children in this country since it was approved and made into law. For years there have been arguments over when life begins. Many say it is at conception and some say it is later in the develop of the fetus. I am one that believes that the beginning of the life of a child happens when the egg is fertilized by the sperm. As I listened to the news the other day, I heard them announce that New York chose to make it legal to kill a child at full term. My heart sank as I listened to them trying to justify reasons why this would be alright. They explained that if a child was going to be born with physical or mental deficiencies, wouldn't it be better to end their life? What kind of reasoning is this? Is it the child's fault if they are born with some form of disability?

Most likely, the problems the child is suffering is due to something the mother has done, whether it be sinning against God, drug use, alcohol, smoking or any other thing she may have done while carrying the child.

My own mother was taking birth control pills while carrying me, and according to the doctors, it is what caused me to have two thumbs on my right hand and two knee caps on my right leg. I shudder to think that if my mom would have known I was deformed, would she have chosen to have me aborted? I don't believe that she would, but many mothers today choose to end a child's life because they are not perfect.

In most cases, doctors call deformities a genetic condition. If it is genetic, passed down from their parents, grandparents or great grandparents, why does it happen? I truly believe that genetic deficiencies are caused by our sin against Almighty God. Exodus 20:5-6 *"Thou shalt not bow down thyself to them, nor serve them: for I the LORD thy God am a jealous God, visiting the iniquity of the fathers upon the children unto the third and fourth generation of them that hate me; And shewing mercy unto thousands of them that love me, and keep my commandments."*

We are all born under the curse of sin, and if we continue in this sin, breaking God's commandments, then that curse, can cause physical damage to a person. If that curse isn't broken through repentance and turning to God, then that curse is passed on from generation to generation.

If our child's life is affected by what we have done or what we are doing now, then why do we punish the child for our own sins?

Many abortions are done because the mother or father make the choice of not wanting the child because of their own indiscretions. Again, I ask, why does the child have to suffer for the

sins of their parents. I have called it sin, because a choice to violate the commandments of God is sin.

When I was in high school, I took a health class. During one of our classes the teacher had all the students watch a film titled, "The Silent Scream." It was a graphic film showing a baby being sucked out of its mother's womb. It left a huge impact on me, because I was not aware of what abortions were.

I read about instances where doctors would inject the woman's uterus with a saline solution that would act like acid and dissolve the baby's body, so that it could be sucked out. I read about them inserting a tool that acted like a blender stick. It was hard for me to understand how someone could live with themselves after doing something this terrible.
